Overview

It has a set tariff rate of 14.25% from February 7, 2024, to February 6, 2025, and 14% from February 7, 2025, to February 6, 2026, ahead of the scheduled tariff expiration date of February 7, 2026. Exempt countries include Canada, Cambodia, Jordan, and Indonesia. The Harmonized Tariff Schedule of the United States (HTS) sets out the tariff rates and statistical categories for all merchandise imported into the United States. The HTS is based on the international Harmonized System, which is the global system of nomenclature applied to most world trade in. Starting in February 2025, the United States introduced a range of "reciprocal" (country-specific) and sectoral tariffs. While public debate has focused on these new measures, they are only part of the story.
