



# Electric vehicle incentives austria



## Overview

With around 480 million euros and lots of Anglicisms, Austria's federal government wants to win over its citizens to electric road transport. 450 million euros will be available by the end of next year to subsidize public charging stations as well as locally emission-free trucks. 60% of the additional costs for the purchase of zero-emission commercial vehicles and 40% of the eligible investment costs for the establishment of e-mobility infrastructure will be subsidized. A total of 83 million EUR will be available for funding in 2025. More information on funding.
