



# Home energy storage battery warranty period



## Overview

A standard battery warranty should come with at least 10 years of protection, though it can be shorter depending on how often you charge and drain your battery. Battery warranties typically won't reimburse for labor costs associated with installing new equipment or shipping fees for. Solar battery warranties vary by manufacturer and product. This article explains industry standards, factors affecting warranty terms, and how to maximize coverage for residential, commercial, and industrial projects. (“LG”) warrants that it will repair or replace defective internal parts (“Part”) of a qualified LG Energy Storage System (each, a “System”) that fail during the warranty period if such parts prove to be defective due to improper materials and / or manufacturing. Although a battery warranty shields you from severe deterioration, adhering to the warranty terms is one of the most critical aspects for maximizing a battery's life. The number of charge and discharge cycles a battery can withstand without decreasing efficiency is known as its cycle life.
