Under the EU's Environmental Impact Assessment (EIA) Directive (2011/92/EU as amended by 2014/52/EU), major building or development projects in the EU must first be assessed for their impact on the environment. This is done before the project can start. For other projects, including urban or. The National Environmental Policy Act of 1969 (NEPA) (42 U. (1969)) requires a compulsory environmental review for any major action, including the construction of utility-scale renewable energy projects.
