



Port vila electric vehicle policy



Overview

The Ministry has bought two EVs to begin implementation of the National Energy Road Map (NERM) and Nationally Determined Contributions (NDC) targets of having 10% of EV's in the Government vehicle fleet by 2030. The two newly acquired EVs, Build Your Dreams (BYD) Yuan Pro Mini-SUVs, will replace the Ministry's existing Kia Sportage vehicles. This pilot project, approved by the Public Service Commission (PSC), will run for the remaining five months of the year, during which the performance and financial.
